This notice briefly describes our privacy policy. 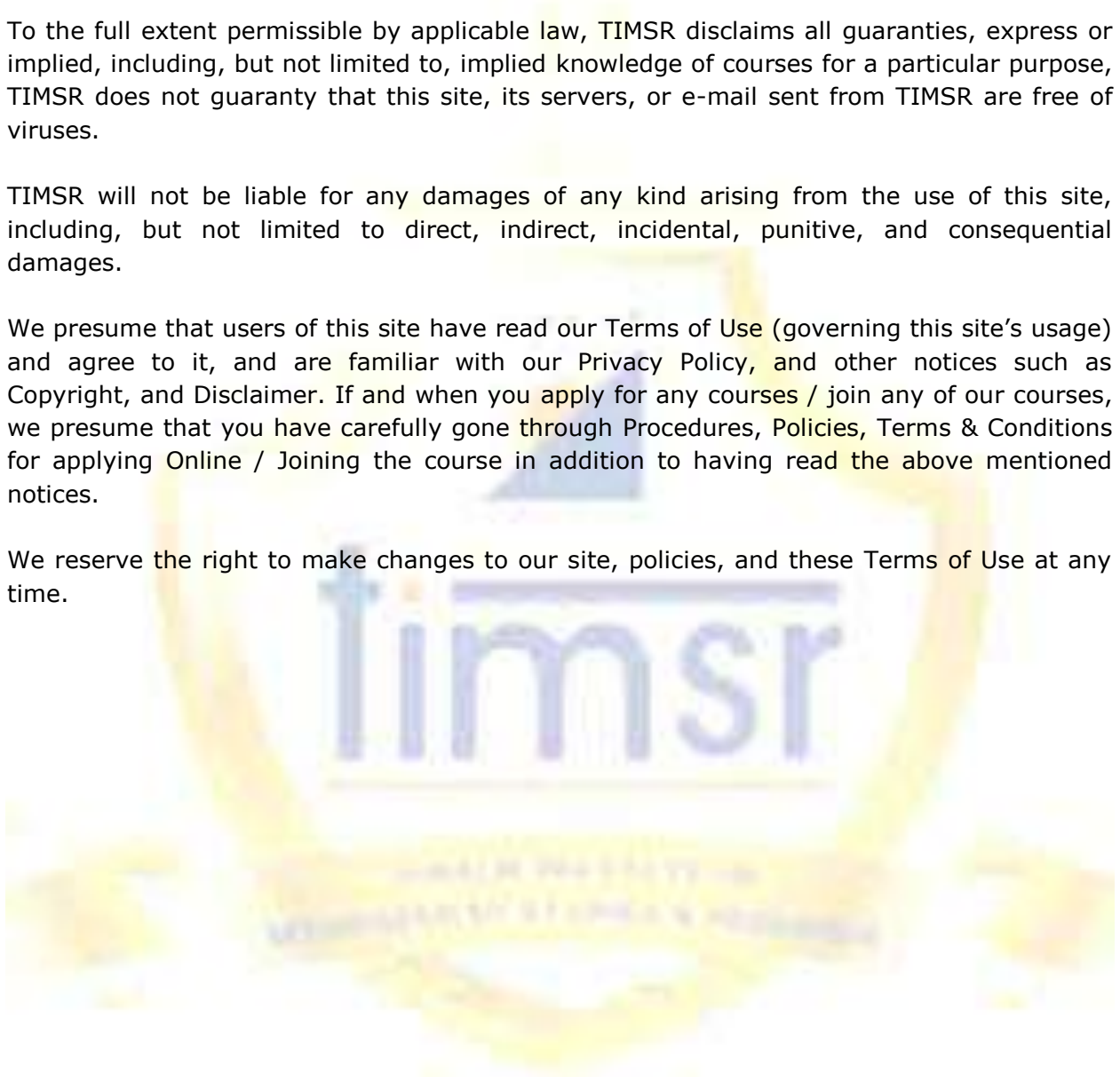

Web Sites Covered

Information Collected

TIMSR offers a variety of educational products and services that are collectively referred to as the "Services." TIMSR collects information from individuals who visit the Company's Web sites ("Visitors") and individuals who register to use the Services ("Aspirants").

When expressing an interest in obtaining additional information about the Products and / or Services, TIMSR requires you to provide the Company with personal contact information, such as name, company name, address, phone number, and email address ("Required Contact Information"). When purchasing the Products and / or Services, TIMSR may direct you to a third party website who is the provider of the Products and / or Services listed in TIMSR's website. These third parties may require you to provide them with financial qualification and billing information, such as billing name and address, credit card number, and the number of employees within the organization that will be using the Services ("Billing Information"). Required Contact Information, Billing Information, and Optional Information are referred to collectively as "Data About TIMSR Customers."

As you navigate the Company's Web sites, TIMSR may also collect information through the use of commonly-used information-gathering tools, such as cookies and Web beacons ("Web Site Navigational Information"). Web Site Navigational Information includes standard information from your Web browser (such as browser type and browser language), your Internet Protocol ("IP") address, and the actions you take on the Company's Web sites (such as the Web pages viewed and the links clicked).

Use of Information Collected

The Company uses Data about TIMSR Customers to perform the services requested. For example, if you fill out a "Contact Us" Web form, the Company will use the information provided to contact you about your interest in the Products and Services.

The Company may also use data About TIMSR Customers for marketing purposes. For example, the Company may use information you provide to contact you to further discuss your interest in the Products and Services and to send you information regarding the Company and its partners, such as information about New Products, Promotions or Events.

TIMSR uses Web Site Navigational Information to operate and improve the Company's Web sites. The Company may also use Web Site Navigational Information alone or in combination with data About TIMSR Customers to provide personalized information about the Company.

Web Site Navigational Information

TIMSR uses commonly-used information-gathering tools, such as cookies and Web beacons, to collect information as you navigate the Company's Web sites ("Web Site Navigational Information"). This section describes the types of Web Site Navigational Information that may be collected on the Company's Web sites and how this information may be used.

TIMSR uses cookies to make interactions with the Company's Web sites easy and meaningful. When you visit one of the Company's Web sites, TIMSR's servers send a cookie to your computer. Standing alone, cookies do not personally identify you. They merely recognize your Web browser. Unless you choose to identify yourself to TIMSR, either by responding to a promotional offer, opening an account, or filling out a Web form (such as a "Contact Us" Web form), you remain anonymous to the Company.

TIMSR uses cookies that are session-based and persistent-based. Session cookies exist only during one session. They disappear from your computer when you close your browser software or turn off your computer. Persistent cookies remain on your computer after you close your browser or turn off your computer.

If you have chosen to identify yourself to TIMSR, the Company uses session cookies containing encrypted information to allow the Company to uniquely identify you. Each time you log into the Services, a session cookie containing an encrypted, unique identifier that is tied to your account is placed in your browser. These session cookies allow the Company to uniquely identify you when you are logged into the Services and to process your online transactions and requests. Session cookies are required to use the Services.

TIMSR uses persistent cookies that only the Company can read and use to identify browsers that have previously visited the Company's Web sites. When you purchase the Services or provide the Company with personal information, a unique identifier is assigned to you. This unique identifier is associated with a persistent cookie that the Company places on your Web browser. The Company is especially careful about the security and confidentiality of the information stored in persistent cookies. For example, the Company does not store account numbers or passwords in persistent cookies. If you disable your Web browser's ability to accept cookies, you will be able to navigate the Company's Web sites, but you will not be able to successfully use the Services.

TIMSR may use information from session and persistent cookies in combination with Data about TIMSR Customers to provide you with information about the Company and the Services.

Web Beacons

TIMSR uses Web beacons alone or in conjunction with cookies to compile information about Customers and Visitors' usage of the Company's Web sites and interaction with emails from the Company. Web beacons are clear electronic images that can recognize certain types of information on your computer, such as cookies, when you viewed a particular Web site tied to the Web beacon, and a description of a Web site tied to the Web beacon. For example, TIMSR may place Web beacons in marketing emails that notify the Company when you click on a link in the email that directs you to one of the Company's Web sites. TIMSR uses Web beacons to operate and improve the Company's Web sites and email communications.

TIMSR may use information from Web beacons in combination with Data about TIMSR Customers to provide you with information about the Company and the Services.

IP Addresses

When you visit TIMSR's Web sites, the Company collects your Internet Protocol ("IP") addresses to track and aggregate non-personal information. For example, TIMSR uses IP addresses to monitor the regions from which Customers and Visitors navigate the Company's Web sites.

TIMSR also collects IP addresses from Customers when they log into the Services as part of the Company's "Identity Confirmation" and "IP Range Restrictions" security features.

Third Party Cookies

From time-to-time, TIMSR engages third parties to track and analyze usage and volume statistical information from individuals who visit the Company's Web sites. TIMSR may also use other third-party cookies to track the performance of Company advertisements. The information provided to third parties does not include personal information, but this information may be re-associated with personal information after the Company receives it.

TIMSR also contracts with third-party advertising networks that collect IP addresses and other Web Site Navigational Information on the Company's Web sites and emails and on third-party Web sites. Ad networks follow your online activities over time by collecting Web Site Navigational Information through automated means, including through the use of cookies. They use this information to provide advertisements about products and services tailored to your interests. You may see these advertisements on other Web sites. This process also helps us manage and track the effectiveness of our marketing efforts.

TIMSR may provide notices, blogs, or chat rooms on the Company's Web sites. Any personal information you choose to submit in such a forum may be read, collected, or used by others who visit these forums, and may be used to send you unsolicited messages. TIMSR posts a list of Customers and testimonials on the Company's Web sites that contain information such as Customer names and titles. TIMSR obtains the consent of each Customer prior to posting any information on such a list or posting testimonials.

Sharing of Information Collected

Unless described in this privacy statement, TIMSR does not share, sell, rent, or trade any information provided with third parties for their promotional purposes. TIMSR may share Data about TIMSR Customers with the Company's service providers so that these service providers can contact Customers and Visitors who have provided contact information on our behalf. TIMSR may also share Data about TIMSR Customers with the Company's service providers to ensure the quality of information provided.

From time to time, TIMSR may partner with other companies to jointly offer products or services. If you purchase or specifically express interest in a jointly-offered product or service from TIMSR, the Company may share Data about TIMSR Customers collected in connection with your purchase or expression of interest with our joint promotion partner(s). TIMSR does not control our business partners' use of the Data about TIMSR Customers we collect, and their use of the information will be in accordance with their own privacy policies. If you do not wish for your information to be shared in this manner, you may opt not to purchase or specifically express interest in a jointly offered product or service.
