The Commission in its meeting held on 27.08.2024 has approved the recommendation of the Standing Committee on Autonomous Colleges to confer the autonomous status on Zagdu Singh Charitable Trust's Thakur Institute of Management Studies and Research, Kandivali (East), Mumbai – 400101, C-Block, Thakur Educational Campus, Shyamnarayan Thakur Marg, Thakur Village, Kandivali (East) Mumbai 400101 for a period of 10 years from the academic year 2024-2025 to 2033-2034 as per clause 7.5 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.

The University, is therefore, requested to issue necessary notification within 30 days regarding the grant of autonomous status to the College as per above mentioned UGC Regulations of Autonomous Colleges, 2023.

The autonomous college is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges, 2023. The Regulations are available on www.ugc.gov.in. Non-compliance of the requirements and conditions prescribed in the said Regulations shall attract action as per Clause -13 of the UGC Regulations, 2023. The college shall apply to University Grants Commission for extension of autonomous status at least three months before the completion of the period of autonomy.

Non-compliance of the above shall attract action as per Clause -13 of the UGC Regulations, 2023.
- (iii) The College is advised to take necessary steps for implementation of NEP 2020 and intimate the same to UGC.
